### **Philosophy**

Kids On Stage strives to make its unique programming available to a diverse group of students from varied ethnic, cultural, and socio-economic backgrounds. The purpose of the Kids On Stage Summer Academy Scholarship Program is to provide financial support to families who would not otherwise have the resources to participate.

Although we would like to be able to award scholarships to every deserving student, scholarship funds are limited.

### **Scholarship Recipient Selection**

Scholarship Application Forms are reviewed by a Scholarship Committee, comprised of Kids On Stage staff and members of the Kids On Stage Board of Directors. The committee bases its recommendations on the qualifications and criteria listed below. Based on committee recommendations, budgetary issues, and any other considerations relevant to the effectiveness and quality of the Kids On Stage Summer Academy program, the Board of Directors gives final approval of scholarship and tuition assistance awards.

Scholarships are awarded without regard to race, creed, color, national or ethnic origin, physical ability, gender, or sexual orientation.

### **Eligibility for Assistance**

Students must:

1. Demonstrate financial need based on the scholarship application. Special consideration will be given to families who are on their school system's free or reduced lunch program.
2. Be accepted for admission to Kids On Stage Summer Academy.
3. Submit Scholarship Application no later than March 30, 2010.

**Scholarship Applications must be submitted no later than March 30, 2010 to be considered for 2010 Summer Academy.**
